<b>Did you know?</b> If fire hoses are no longer required in your building, you cannot simply remove the hoses from your fire-hose cabinets. The hose rack and associated hardware in each cabinet must also be removed in order to avoid an "inoperable fire safety system" deficiency on your REAC Inspection.
